## H.O.P.E. Grant – Application Detail Form

The goal of H.O.P.E.'s grant program is to enable supplementary financial support to Heyworth Elementary staff for the end benefit of student education/enrichment. 1. Describe the proposed need/project/program and the objectives it would accomplish.

RTI is requesting 6 chromebooks to keep in the RTI classroom. We are finding that the updated interventions that we use often times have online components that require the students to have access to a computer. Currently, we only have 6 desktops in the RTI classroom. Due to the age of these computers they often time require maintenance that cause them to be unavailable for extended periods of times. At this time there are 52 kindergarteners and 1st graders that receive RTI services. These students are not 1:1 in their classrooms, therefore they do not always have access to a chromebook to bring to RTI.

2. What is the estimated cost of the project/program? Please summarize and attach itemized list.

I have spoken with Dan Zoebel, our Technology Director, and he said that he can order and maintenance the chromebooks. The quote he gave me was \$228.50 per chromebook, which includes the Chromebook and Google License. For 6 Chromebooks the total cost would be \$1371.00.

3. Who and how many would benefit from this project/program? What would be the impact on students/staff?

Currently, RTI is servicing about 100 students in some capacity. These numbers fluctuate based on the needs of the students from benchmark to benchmark and from year to year. RTI is the primary means of intervention that we use in the Heyworth Schools. The goal and purpose of the interventions is to keep kids that may fall behind on track with their peers. By having students utilize the online components of the programs they are getting more individualized lessons. The benefit of the online components would allow the students to progress more quickly through the programs and close the educational gaps. The students would then be able to be dismissed from the RTI in a more timely manner.
