This would allow me to display more art and it could be left up to enjoy after the Art show. I would use them other times in the year to display pop up exhibits, highlighting a specific project or grade. They could also be a convenient way to quickly hang student work for critiques during class. Also, many of my Illinois Art Standards cover children making their own art displays and exhibits. I would be able to better meet those standards with these display panels. Other teachers in the building would be welcome to use them as well.

Three sets of 2, V-shaped panels cost $\$ 121.50$ each bringing the total of all three to $\$ 364.50$. There will also be a charge for shipping and handling (around \$50-\$70).
